#### FROM THE SECRETARY OF CONVENTION



Beginning Friday, November 15 at 1:00 pm, with check-in commencing at 10:00 am, our Diocesan family will gather for the 158th Convention at the Melville Marriott Long Island Hotel located at 1350 Old Walt Whitman Road in Melville to celebrate our common life and ministry and to do the work of Convention. To assist delegates and visitors to this year's Diocesan Convention, the following packet of information is provided to enable you to be well informed as to the happenings and events of the Convention. The following information is being provided in response to frequently asked questions from previous years.

All Convention attendees MUST register online, pay the appropriate registration fee.

If you are in the Convention Hall you MUST have a badge visibly displayed.

- Upon arrival at the hotel, please go to the appropriate **Check-In Desk:** 
  - all voting clerical, lay delegates, youth delegates and non-voting alternates check in at the Main Lobby starting at 10:00 am. There will be separate desks for clergy and lay delegates.
  - all visitors (lay and non-voting clergy) check in at the Main Lobby as well. There will be a separate line for visitor registration.
  - On Friday after 2:00 pm and on Saturday beginning at 8:00 am, all check-ins will take place in the foyer outside the Convention Hall.

(The Diocesan Check-In Desk will be staffed from 10:00 am to 7:00 pm on Friday and 8 am to 2 pm on Saturday)

Those staying overnight at the hotel should go to the hotel's front desk for directions on luggage storage until rooms are available.

- At the Diocesan Check-In Desk you will receive your badge, which is required for admittance to the Convention Hall, recording your attendance, receiving your voting card, receiving a Liturgy Booklet, seating and group meals. Once you have checked in, please find a seat; delegates should sit together in designated areas. You may also visit exhibitors located in the atrium, the foyer and in the hallways outside the ballroom. Youth Delegates will have designated reserved tables. Voting ballots and other important handouts will be placed at each seat. There will be a "Convention Material" table located in the rear of the Ballroom with extra copies.
  - Badges with GREEN, ORANGE or BLUE lanyards identify delegates who are to sit on the Convention Floor.
  - **Badges with TEAL lanyards** identify visitors and non-voting alternates for whom seats are provided at the rear of the ballroom.
  - Everyone seated at the tables on the convention floor **must** have a badge with a green, orange or blue lanyard visibly displayed at all times. This area is restricted to voting delegates and church-appointed youth delegates. Clergy in charge of congregations with an TEAL lanyard who are not eligible to vote are permitted to sit with their delegation. Space constraints do not allow others to be seated in this area.
  - At the close of the Convention, receptacles will be provided at the exit doors to collect badges, and voting smart cards.
  - Pre-Convention Journals **will not** be mailed to delegates. The Journal is available electronically on the diocesan website and in the Convention App. Copies of the Journal will be distributed to voting delegates (lay and clergy) and youth delegates at check-in.

■ You will need to bring to Convention a church check or credit card bearing your church's name on its face, and your church's tax exemption certificate if you are staying at the hotel and wish to receive exemption from sales tax on your hotel bill. Sales tax exemptions will not be honored when using a personal check, personal credit card or cash to pay the bill.

#### **Alternate Delegates:**

- If an Alternate Delegate has registered to attend Convention and will be voting in place of their delegate, a Testimonial of Change must be submitted to convention@dioceseli.org no later than November 2.
- Alternate delegates who are not voting still need to register to obtain a badge to admit them into the Convention Hall and sit in the Visitor's Section.

Hotel Check-in is 3:00 pm. If rooms become available earlier, an announcement will be made.

**Hotel Check-out** is 12 noon on Saturday so please clear your room of your belongings prior to the start of the Convention Saturday morning. Luggage can be stored for you until the close of the Convention. Inquire at the hotel registration desk for details.

**Coffee** will be available in the foyer outside of the Convention Hall until 1:00 pm on Friday. There will be a coffee break on Saturday morning following the Eucharist.

#### Meals during Convention:

"Tickets" to the Convention **Banquet** on Friday night are sold prior to the Convention; the purchase option is noted on the Convention Registration Form online. If you paid for the dinner and were not provided with a QR code, please see a staff member at the **HELP desk**.

**Breakfast** on Saturday is being provided to anyone reserving a hotel room under the Diocesan room block. If you did not reserve a hotel room under the Diocesan Room Block, you may have breakfast in the Hotel Restaurant at your own expense. Breakfast tickets will be provided by the hotel staff when you check into the hotel.

Saturday's **Lunch** is included in all Prepaid Registration fees; therefore, if you registered for this Convention online you will be provided lunch at no additional cost. **Please select a meal from the options provided when you register for the Convention.** Tickets for the Convention Dinner on Friday night or tickets for Lunch on Saturday <u>will not</u> be sold during Convention.

- 2. Renumber the remaining sections as Section IV (Capital Expenditures), Section V (Resignations), Section VI (Transfer of Property), Section VII (Petition to Revert) and Section VIII (Properties on Reversion).

Existing Title VII, Canon 4, Section IV is duplicative of existing Title VII, Canon 4, Section VII. It should therefore be deleted and the balance of the sections be renumbered.

AMEND TITLE VIII, CANON 2, SECTION III SUBSECTION (b) (MEMBERSHIP) as follows:

1. Insert the word "confirmed" before the phrase "adult communicants"

#### **EXPLANATION**

This change is required to bring the Membership qualifications of the Cathedral chapter into line with other Diocesan corporations. In June 2024, the Cathedral Chapter adopted a change to its constitution adding this requirement.

AMEND TITLE VIII, CANON 1 SECTION II, SUBSECTION (a) as follows:

- 1. Delete existing Title VIII, Canon 1, Section II(a) in its entirety.
- 2. Insert new Title VIII, Canon 1, Section II(a) as follows:
- "(a) <u>Composition</u>. The membership of the Board of Manages of Camp DeWolfe shall be composed as follows:
- (i) ex officio members: (a) The Bishop of the Diocese of Long Island and (b) the Executive Director of Camp DeWolfe
  - (ii) four persons appointed annually by the Bishop of the Diocese; and
- (iii) six persons elected by the Diocesan Convention. Two persons shall be elected at each successive Diocesan Convention for terms of three (3) years. All members elected by Convention prior to the enactment of this amendment shall remain in office until their current terms expire.

Proposed Ministry Plan for Diocese of Long Island 2024

#### I. Introduction

The Ministry Plan (aka budget) for 2025 that is before this convention represents the faithful stewardship of our congregations, the Trustees of the Estate Belonging to the Diocese of Long Island, and all the corporations that constitute the ministry of the Diocese of Long Island. It represents the best efforts of our diocese to provide ministry in Brooklyn, Queens, Nassau, and Suffolk as we continue to adjust and move past the impact of the world-wide pandemic. As you examine this Ministry Plan, you will discover the outward and visible expression of our collective support for the programs, initiatives, and personnel that are our diocesan ministry. This ministry plan provides significant support and attention to the further development of clergy and lay leadership for our parishes, the continued encouragement of our diocesan-wide ministries, and the on-going initiatives of pastoral, liturgical, and social ministries across the Diocese and beyond.


The narrative that follows gives expression to the way of love in Jesus Christ that makes holy sense of the numbers and figures of the budget for 2025.

#### II. Sources of Revenue

The Diocese Ministry Plan is funded by four sources of revenue:

- ➤ Congregational Offerings: \$3,722,619 (39%)
- ➤ Trustees of the Estate: \$5,352,230 (55%)
- ➤ Astor Fund Grant: \$122,280 (1%)
- ➤ Service and Other Revenue: \$517,000 (5%)

#### Revenue 2025




- Congregational Offerings for the Support of our Common Ministry: \$3,722,619 (39%)
  Offerings from congregations represent 39% of the proposed Ministry Plan. The goal for 2025 is a pledge of a tithe (10%) of the actual income in each parish over the past three years in direct support for the diocesan ministry plan. One Diocese, One Mission is represented in the mutual responsibility and inter-dependence actualized when each congregation offers a tithe of actual income in support of our common ministry.
- Trustees of the Estate Belonging to the Diocese of Long Island: \$5,352,230 (55%)
  In light of the continuing effect of the economic impact of the COVID-19 Pandemic, and the direct impact on household income, 55% of the revenue in the 2025 Ministry Plan comes from the Trustees of the Estate in several types of support. Income from trust funds held by the Trustees of the Estate support the Episcopate, Mission, and maintenance expenses. The Trustees continue to support the Cathedral and Diocesan Center through the Ministry Plan and will provide additional support to the Diocese.
- Astor Fund Grant: \$122,280 (1%)

  The Diocese is the beneficiary of income from the Astor Fund held by The Episcopal Church for mission in the City of New York. Income is allocated to projects in the City.
- Service and Other Revenue: \$517,000 (5%)
  As in prior year accounting and administrative fees are received for services provided to other Diocesan corporations.

Expenditures amounting to \$9,714,129 in the 2025 plan can be broken down into three broad categories:

- ➤ Mission: \$6,606,279 (68%)
- Episcopate and the Bishop's Staff: \$2,374,855 (24%)
- Administration & Facilities Expenses: \$732,995 (8%)



Mission: \$6,606,279 (68%)

Congregational Development: \$48,599 (1%) This Plan continues to support the Diocesan Church Development Institute (DCDI) program, a leadership-training program focused on developing the spiritual community and organizational life of congregations. DCDI continues to support and train clergy and lay leaders who desire to transform their congregations by making them stronger, healthier, more deeply rooted in Anglican Spirituality, more responsive to God, and more effective in their communities. It also funds congregational coaches who work one on one with clergy and vestries.

Retired Clergy/Lay Programs: \$132,000 (1%) A diocesan initiative that provides annual grants to retired clergy and surviving spouses to assist with medical expenses. The Diocese provides a Medicare Supplement to retired lay staff with 20 years' service.

Community Justice Ministry: \$135,885 (1%) This full-time position focuses on the bishop's work with community justice matters and the support for the work of the Creation Care ministry.

Diocesan Convention: \$264,974 (3%) Funds the direct administrative and program expenses related to producing our Diocesan Convention. This includes the listening sessions, preconvention meeting, production and distribution of Pre-Convention Journals, registration system, hotel accommodations, transportation and meals for diocesan staff, lunch and coffee breaks for attendees, banquet, Youth and Young Adult programming, childcare, audio-visual services, equipment rental and services such as electronic voting. This line item funds one staff person who dedicates a portion of their energies throughout the year to the planning of convention.

Diocesan Youth and Young Adult Ministry: \$295,231 (3%) Supports programming and the salary, benefits, travel, and related expenses for the Director of Youth and Young Adult Ministries.

Communication Ministry: \$370,922 (4%) Office of Communication Ministry (OCM) provides counsel to the Bishop and diocesan departments and parishes. OCM helps to plan effective strategic communication and interpretation of mission and ministry, both within the church and the general public. OCM also manages the Information Technology computer network and business databases for all diocesan offices and offers staff training and a help desk for use of office computer programs. OCM is also responsible for the administrative management of the communication, logistics and related arrangements for Diocesan Convention. OCM is the producer, editor and publisher of articles, notices and video content for the diocese's official website and social media networks. OCM staff writes, edits, and publishes online email newsletters for parish clergy and lay leaders, and posts official email announcements. The Director of Communication manages all of the above and also serves as the official press spokesperson for the diocese and is the frontline liaison for Bishop Provenzano with church and secular print and electronic news media.

**Support for the Wider Church:** \$434,255 (4%) This is our share in the Triennial Ministry Plan of The Episcopal Church and our participation in the work of Province II. Funds are also reserved for our deputation to General Convention and the Lambeth Conference. The Ministry Plan includes the full asking of the Episcopal Church.

#### Missioners & Partnerships: \$3,841,459 (40%)

**Missioners:** Strategic church plants, mission support, church redevelopment, and new mission initiatives. Missioners are paid through the Diocesan payroll.

Administration & Facilities: \$732,995 (7%)

Administrative Expenses: \$201,775 (2%) Annual audit, legal, office expenses and equipment.

Facilities & Maintenance: \$531,220 (5%) Responsible for the buildings and grounds on the diocesan campus and other properties managed by the diocese. This line item includes the salary and benefits of the Director of Facilities and ground's crew who serve on the Diocesan and Cathedral Campus. Facilities and Maintenance also serves the wider Diocese by providing insight and analysis to local parishes engaged in construction and maintenance projects. The Cathedral and Mercer School contribute to these expenses and the Trustees of the Estate also provide support.

#### Episcopate & Bishop's Staff: \$2,374,855 (24%)

**Diocesan Bishop:** \$334,930 (3%) Covers the salary, benefits, travel, and related expenses of Bishop Provenzano.

Assistant / Assisting Bishops: \$152,113 (2%) Covers the salaries, benefits, travel, and related expenses of Bishops Wolf, Allotey, and Franklin.

Coordinator of Deacons: \$18,080 (.5%) Covers the salary, benefits, travel, and related expenses for the Coordinator of Deacons who supports the work of the Bishops.

Chancellor's Office: \$395,327 (\$4%) Covers the salary, benefits, travel, and related expenses for the Chancellor and a paralegal who support the work of the Bishop.

**Bishop's Lay Staff: \$457,912 (5%)** Provides support for the Episcopate, the Canons, and Diocesan Sponsored Events.

Administrative Staff: \$1,016,493 (10%) Includes support for Diocesan Convention, Finance Office, Human Resources, Payroll, and Youth and Young Adult Ministry

BE IT RESOLVED that this 158th Convention of the Episcopal Diocese of Long Island recommends that Lay Employee's Compensation for 2025 be increased by a 1.8% Cost-of-Living Adjustment (COLA) and all benefit eligibility be reviewed in accordance with the following table:

Discontinuing single-use plastic products, single-use foam products, and single-use water bottles at Diocese of Long Island churches and facilities

# Proposed resolution: Discontinuing single-use plastic products, single-use foam products, and single-use water bottles at Diocese of Long Island churches and facilities

**Resolved,** that this 158th Convention of the Episcopal Diocese of Long Island, acting consistently with General Convention Resolution 2009-A-045, and with New York State's 2022 ban on polystyrene containers for food service businesses, call upon all churches, schools, conference centers and offices of the Diocese to **immediately discontinue** the use of disposable, single-use Styrofoam and foam products including but not limited to plates, cups, and food containers; and be it further

**Resolved**, that that this 158th Convention call upon all churches, schools, conference centers and offices of the Diocese of Long Island **to discontinue within four years** the use of single-use plastic products, including but not limited to: plastic water bottles, plates, cups, cutlery, straws, coffee pods, food wraps, and bags; and be it further

**Resolved**, that this 158th Convention call upon all churches, schools, conference centers and offices of the Diocese of Long Island **to transition within four years** to reusable, compostable, and washable alternatives and away from single-use plastic products, single-use foam products, and single-use water bottles unless health and safety considerations require otherwise.

#### **Background:**

General Convention Resolution 2009-A-045 states:

Resolved, That the 76th General Convention ask the Church to restrict the use of bottled water at General Convention and at other Church-sponsored activities where safe, because of the extreme negative environmental impact that attends its production; and be it further

Resolved, That every baptized Christian be encouraged to practice simple energy and water conservation techniques so that, by working together, we may restore the beauty of God's creation and ensure that this resource may again be available to all God's children in abundance.

#### Rationale:

Since the 1950s, 8.3 billion tons of plastic has been produced worldwide. Plastic is a non-biodegradable product. Most of the plastic ever produced in the history of the world still exists in some form. Some 91% of it is never recycled and ends up in landfills or the open environment. Roughly half of the world's plastic production is dedicated to single-use products such a packaging, food containers and water bottles.

The following is a brief list of statistics about plastic and Styrofoam waste:

- 500 billion disposable cups are consumed every year in the USA.
- Americans alone throw away 25 billion Styrofoam coffee cups every year.
- Styrofoam cannot be completely recycled. Most of the Styrofoam disposed of today will still be present in landfills 500 years from now.
- 32% of the 78 million tons of plastic packaging produced annually is not recycled or sent to landfills. It is left unmanaged and flows into the world's oceans through streams and rivers.
- 90% of the trash in the world's oceans is plastic, roughly 46,000 pieces per square mile.
- Improper waste management is a global crisis. If plastic pollution continues at its current rate, it is predicted that plastic will outweigh all fish in the oceans by 2050.
- The Episcopal Church identified Care of Creation as an integral part of the Jesus Movement in Resolution A013 at the 79th General Convention in 2018. In passing this resolution, the Episcopal Diocese of Long Island has an opportunity to play a leadership role in the Episcopal Church's mission of environmental stewardship and provide an example of practicable waste reduction.

#### EPISCOPAL REAL ESTATE OF LONG ISLAND REPORT (PART A)

2024 ERELI Asset Management



Created in 2020, Episcopal Real Estate of Long Island (ERELI) assists with the management of diocesan real estate by providing construction, asset management and general administrative services to our parishes.

Within ERELI, the Construction Management team is comprised of Anthony Natale and Tina Kurek). The Asset Management team is comprised of Ellen Liu Chan and Ariel Curry. Jennifer Kosky provides general real estate administrative services for our parishes.

In 2024, the Asset Management team worked hard at negotiating a 99-year ground lease involving property owned by St. Gabriel's Hollis, paving the way for the construction of a 280-bed, 110,000 SF nursing home. As of the writing of this report, the transaction is awaiting signature and will require court approvals before going into effect.

The sale of a historic but dilapidated residence in Riverhead allowed our Construction Management team to renovate the closed buildings at Grace Episcopal Church in Riverhead. The renovation is expected to finish this Fall, after which the space will be occupied by Iglesia de la San Francisco, the mission that was created at last year's convention. The space will also house programming space for Rural Migrant Ministries, an important ministry partner on the East End of Long Island.

The former site of St. Paul's Church in Woodside was also sold earlier this year. Due to the property's limited zoning potential and poor condition following an extensive fire in 2007, the difficult decision was made to sell the property and allow us to focus resources toward projects with greater impact.

We also continued to work through feasibility studies at several locations, St. James Elmhurst, St. Bartholomew's in Brooklyn, Grace Church Jamaica and Iglesia de la Santa Cruz, where we are recipients of a pre-development grant from Trinity Church Wall Street.

In Central Islip, we are hard at work imagining the new church property at 53 Carleton Avenue following the Messiah Church's devastating fire in June 2023. We are in touch with the Town Planning officials at the Town of Islip and an experienced architect to create a plan that both sustains the church as well as embraces the town's revitalization plans on Carleton Avenue.

Outside of development focused work, we continue to think creatively about shorter term revenue generation opportunities. Our office is methodically rolling out a partnership with Backlot, a third-party service that assists with marketing our spaces for film and movie production functions. We also continue to negotiate lease renewals, establish new leases and handle tenant requests for Trustee owned property, maintaining a steady and growing cash flow.

In the public sphere, we continue to be involved in the rezoning initiatives citywide (City of Yes), in Crown Heights (AAMUP – Atlantic Avenue Mixed Use Plan) and Jamaica (Jamaica Neighborhood Plan), maintaining a steady relationship with city agency officials to make sure our voices and interests are heard.

This highlighted selection of projects is just a small snapshot of the work that Asset Management is involved in. We encourage parishes to reach out to us with their real property needs.



2024 ERELI Construction Briefing



The ERELI construction team successfully completed 41 projects during 2024. This at a cost of \$4,884,676.00. Below are notable projects in progress or completed:

## **Brooklyn**

- <u>Holy Apostle Winsor Terrace Brooklyn</u> the successful completion of renovations and reconstruction of the failing rectory bathroom bump out to a safe more efficient bathroom.
- St Andrew Sunset Park Brooklyn the interior and exterior of the Church are in the process of being renovated. In addition to addressing deteriorating and existing hazardous conditions many upgrades will be added including a welcome atrium and an elevator that will provide handicap accessibility to all levels of the Church. These renovations will allow St Andrews to better serve the community and increase its congregation. This project is slated to be completed by the late spring of 2025.
- St Ann & the Holy Trinity Brooklyn Heights Brooklyn the study for the renovations to this magnificent Church which serves as our pro-cathedral is near completion. This will allow for the development of a 10-year plan of restoration to bring this Church back to its original glory.
- <u>St Johns Park Slope Brooklyn</u> completion of the renovations to the adjoining parish owned brownstone along with the obtaining of the Certificate of Occupancy by the City of NY allows St Johns to now rent the income producing apartments.

## Queens

• Grace Resurrection, East Elmhurst – the existing one family rectory that is in disrepair and currently uninhabitable is in the process of being converted into a beautiful two-family residence. These two newly renovated apartments will bring much needed revenue to the parish and complement all other renovated homes on the block. This project is slated to be completed in the winter of 2024.

## Nassau

- <u>Cathedral, Garden City</u> the altar was successfully restored, bringing it back to its original
  design. The restoration resulted in improved flow making the altar feel more inclusive and
  accessible as intended.
- <u>Cathedral, Garden City</u> the designing of the creation of a 1200 niche columbarium that will be located in the Cathedral undercroft has been completed. The projected start date for this project is the spring of 2025.
- <u>Incarnation Chapel, Carle Place</u> in coordination with the Cathedral of the Incarnation the successful redesign of the parish hall located on the campus of the former historic St Mary's Episcopal Church has been completed. Incarnation Chapel is now a center for worship, study, and mission.
- <u>St Pauls, Roosevelt</u> the unsafe surrounding sidewalks that were in total disrepair have been replaced. This successful project allows parishioners and passersby to safely walk in all areas around the Church property.

#### Suffolk

- <u>Christ Church Babylon</u> the successful completion of renovations to the existing rectory has allowed the new priest in charge, along with family to move into a comfortable residence.
- <u>All Souls Stony Brook</u> renovations to the Mill Pond school have been successfully completed. This work included a new roofing and drainage system, window replacement, entrance railings, electrical upgrades, and many other necessary fixes to allow the children to learn in a safe and comfortable environment.
- <u>St Davids Riverhead</u> major renovations to the existing Church, parish hall, chapel and kitchen have been successfully completed. The reopening of this ministry will serve the community well for years to come.
- <u>Camp DeWolfe</u> essential repairs to the failing and storm damaged stairwell have been successfully completed. This now allows campers and all people accessing the beach to do so in a safe manner. Additionally, repairs to the bluff have been completed, this to prevent further erosion.

ERELI construction is currently overseeing 16 active projects with total costs of \$7,857,000.00.

ERELI construction has <u>25</u> upcoming projects slated to begin late 2024 or in 2025, these projects are in various stages of commencement with a value of <u>\$8,682,000.00</u>.

During 2024 ERELI construction has value engineered and performed interior design services on many projects eliminating the need and cost of outside vendors. This produced a <u>15%-20%</u> savings to the final project cost.

Our administrator, Jennifer Kosky, informs and assists parishes located in Brooklyn and Queens with their NYC Water Exemptions application and renewal process. Church Insurance has been working with Jennifer to review and update information to ensure accurate property and liability insurance. Additionally, Jennifer reviews and approves all utility bills and contracted payments for trustee owned properties.

Jennifer continues to streamline the real estate property tax exemption renewals and application process for trustee owned properties, ensuring accurate and on time submissions.

In addition to her duties with the ERELI construction team, Tina Kurek has been working diligently with many parishes clearing up outstanding NYCDOB violations. During 2024 ERELI migrated to one platform for violation notification and settlement, this to reduce costs and improve efficiency.

ERELI has completed a rollout and initial training session to keep all parishes educated and informed on the clearing and understanding of violations.

## EPISCOPAL HEALTH SERVICES (EHS) REPORT





Episcopal Health Services, Inc., (EHS) is a health system that services the residents and communities of the Rockaway Peninsula. It consists of St. John's Episcopal Hospital (SJEH), the only hospital providing emergency and acute care to the densely populated, culturally and economically diverse community. EHS also provides Primary Care, Cancer Care, Women Services, and other Specialty Care through its St. Johns Medical Group (SJMG) ambulatory physician practices across the Rockaway Peninsula. Through its Innovative Health Partners (IHP) Association, EHS works with physicians to ensure coordinated services on the peninsula. Its philanthropic arm, St. John's ICARE Foundation (ICARE), was established to support the strategic priorities of St. John's Episcopal Hospital. EHS ensures residents on the Rockaway peninsula have access to quality healthcare near their homes.

In 2023, the health system launched a re-branding strategy specifically designed to re-educate stakeholders about who we are and the many services the system has to offer. This year we are proud to report, that the health system continues to work through its strategic plan which focuses on five (5) key areas: **Enhance Patient, Family and Team Member Experience, Improve Financial Performance, Build and Invest in** 

4-5 Key Service Lines, Improve Community Health Outcomes and Improve Public Awareness and Reputation Management.

The Health System is also undergoing system-wide construction, which includes, but not limited to, upgrades to patient floors, infrastructure and energy efficiency transformation and external capital construction. The focus is to provide patients, care partners and team members adequate space to heal and work. Set to open in 2025, the Walsh Ambulatory Pavilion (pictured right), located across the street from SJEH. The pavilion will feature a comprehensive cancer program, with Radiation Oncology, a PET CT



scan and a Linear Accelerator. It will also offer primary care with embedded social work services, outpatient Behavioral Health services and an endoscopy center.

It is also important to note the many prestigious accolades the health system has earned in recognition of its commitment to excellence in patient care. SJEH was named a 2023-2024 U.S. News & World Report High Performing Hospital for Diabetes and received the 2023 American Heart Association's Gold-Plus Get With the Guidelines® Stroke and Heart Failure Quality Achievement Awards. In closing, EHS is committed to providing high-quality, patient-centered care to the Rockaway Peninsula. Through strategic growth, new facilities, and a focus on excellence, EHS continues to enhance the patient experience and improve community health outcomes.

### SACRED GROUND CORPORATION REPORT

# **Sacred Ground Corporation Report 2024**

Sacred Ground is an eleven-part series on race, grounded in faith. Part of the Episcopal Church's commitment to Becoming Beloved Community, Sacred Ground uses documentary films and readings to walk small groups through chapters of America's history of race and racism, while inviting participants to weave in their own family stories. Participants spend roughly three hours preparing for each session.

In Bishop Provenzano's 2023 convention address, he asked every parish of the diocese to encourage participation in Sacred Ground in their congregation, neighborhood and wider community, saying that "reconciliation can only happen when awareness is clear, hearts and minds changed...This is gospel work, and it is our ministry to accomplish creating Beloved Community."

More than 300 people have participated in Sacred Ground through the diocese of Long Island since 2021. In 2024, roughly 60 people completed the series for the first time, assisted by 12 experienced facilitators. The program will be offered again through the diocese, over Zoom, in February 2025. Registration will open at this year's diocesan convention.

# Report to the 158th Convention of the Diocese of Long Island

Episcopal Ministries of Long Island (EMLI) brings the love of Jesus Christ from the pew to the public square by nurturing, resourcing, and amplifying ministries across Brooklyn, Queens, Nassau, and Suffolk.

2024 has been another year of growth for EMLI, with a 52% increase in grant applications compared with 2023. Our ability to meet this demand speaks to the generous support of the people of this diocese and our commitment to ensuring parishes have the resources they need to serve their communities effectively. In total, EMLI distributed over \$151,465 in grants so far this year, supporting 25 active parish ministries. By the end of the year, a record total of \$175,000 will have been expended on parish grants alone. Additional funding is provided to other uniquely qualified diocesan ministry partners like Camp DeWolfe, North Brooklyn Angels and Rural and Migrant Ministry.

EMLI-supported ministries reached over 50,000 people in need. This includes the distribution of over 237,000 meals and over 5,300 hours of education for children, teens, and seniors. One thousand volunteers across our diocese contributed 34,000 hours to make this possible.

EMLI continued to build ministry capacity by offering several training workshops designed to empower parishes with practical skills and community-building strategies. Communications Manager Mary Grace Puszka and Teddy Byrne from the diocesan Office of Communications Ministry led a Communications Workshop focusing on improving digital presence and content strategy. Participants learned how to conduct communications audits, enhance website user experience, create engaging short videos, and boost social media engagement. Attendees praised the workshop as full of "handson experience," with one participant noting they were already implementing new strategies at their parish. Additionally, EMLI hosted an Asset Based Community Development (ABCD) training for St. Joseph's, Queens Village. This session guided participants in identifying and harnessing community gifts to live out their Baptismal Covenant commitments.

We also continue to foster new and innovative ministries responding to the urgent needs of our communities. From food insecurity to affordable childcare, parishes have stepped up to be the hands and feet of Christ, offering solutions and support at every level.

In October, EMLI welcomed over 240 guests to our annual Celebration of Ministry honoring the Garden and Pantry at St. Peter's by-the-Sea in Bay Shore. This collaborative organic garden and food ministry address food insecurity while fostering community. They embody our mission of bringing Christ's love "from pew to public square."

Our goal as we plan for the coming year is to continue expanding our support for ministries that directly address the most pressing needs in our diocese – from food insecurity and childcare to fostering connections and building meaningful community partnerships. However, with increased growth comes the challenge of sustainability, and we remain mindful of the need to strengthen our fundraising efforts to match the increasing demand.

Your ongoing commitment to EMLI allows us to resource, nurture, and amplify ministries transforming lives throughout our diocese. With your support in recent years, EMLI has worked diligently to build capacity, equipping us to better support resilient ministries, build donor relationships, and respond to both urgent and long-term community needs with clarity and vision. Thank you for supporting the mission and ministry of the Diocese of Long Island.

## CREATION CARE COMMUNITY (CCC) REPORT

During the past year the Creation Care Community Leadership Team has grown to 10 persons, six clergy and four lay. Our main focus has been on building the community, and taking concrete action to further the work of Creation Care throughout the Diocese. That has included spreading the word through parish visits and through improved communication and collaboration outside the Diocese.

Our activities and achievements in the past year include:

# Advocacy:

#### NY Renews

We have continued to play an active role in the campaigns of New York Renews, the legislative coalition that secured the passage of the Climate Leadership and Community Protection Act, and continues to put forth progressive environmental justice legislation for New York state. Our Missioner serves on the Organizing Committee of New York Renews, and was in Albany with other faith leaders at the end of this year's legislative session to lobby for the current package of environmental bills advanced by NY Renews.

#### • Birds and Bees Protection Act

Last year we reported that Bishop Provenzano and Peter Cook, Executive Director of the New York State Council of Churches, had written an op-ed for the Long Island Press in support of the Birds and Bees Protection Act, which prohibited most uses of neonicotinoid pesticides (neonics) in New York state. The environmental impact of neonics is very similar to that of DDT, so it was a major step forward when Governor Hochul signed the Act into law last December.

# **Emissions Reductions/Reducing Our Carbon Footprint**

## Going Solar

A number of parishes have signed on to the solar project from CCC's collaboration with the Long Island Progressive Coalition. It has attracted attention in the wider community. On September 16, Newsday featured a full-page article entitled "Solar Project is Church's Calling," about the installation of 87 solar panels at St. Mark's Islip. The article also mentioned the completed solar project at St. Francis North Bellmore, and quoted the Bishop on the Diocese's aspirations to expand renewable power across the Diocese. Four other parishes are currently working on solar projects, and we hope to hear from others who are interested in doing the same.

## • Installing Dishwashers and Planting Trees

In 2023, EMLI awarded a grant of \$20,000 for a pilot program to install commercial dishwashers in parishes aiming to eliminate their use of disposables. Transfiguration Freeport, St. George's Hempstead, and St. Paul's Patchogue have installed or repaired commercial dishwashers, and one other parish is pending. EMLI also gave \$5,000 for planting and preserving trees as part of the Bishop's Canopy 2030. Among the awardees for trees are St. Ann & the Holy Trinity (Brooklyn); St. Jude's, Wantagh (Nassau); and St. James of Jerusalem (Nassau).

# Building the Community

#### • Earth Day

We held our second diocese-wide celebration of Earth Day, on Saturday April 20th at the Cathedral of the Incarnation. Clergy and laypersons from across the Diocese attended the special Eucharist, with Bishop Provenzano presiding. Representatives from Brooklyn, Queens, Nassau, and Suffolk were presented with native plants and shrubs for planting to kick off the Bishop's Canopy 2030, aimed at increasing tree cover in the diocese by 50% by 2030.

#### • Green Team Retreats

CCCDLI held two successful Green Team Retreats, in fall 2022 and 2023. As of the time of writing, the 2024 retreat has not yet taken place. The Green Team retreats are aimed at helping those interested in Creation Care find focus areas. The retreats cover: 1) reducing greenhouse gas emissions; 2) advocacy; 3) nature conservation and preserving biodiversity; 4) reduce/reuse/recycle aimed at reducing consumption at home and in our parishes); and, 5) community engagement.

## • Improved communication

With the help of the Diocesan Communication Office, this year we launched a dedicated web page on the diocesan site. It provides information on all our activities and priorities, and allows wider dissemination of our quarterly newsletter. Our mailing list of those interested in Creation Care has grown to over 250, and we aim to double this in the next year.

#### • Wider collaboration outside the Diocese

We have made contact with leading voices on climate, including H.E. Mia Amor Mottley, Prime Minister of Barbados, and hope she will be able to join us for an event in the coming year. We have also established links with the Creation Care team of the Diocese of New York, and plan to work together on training and other projects especially those that involve our New York City counties.

Bishop Provenzano was one of 49 diocesan bishops of the Episcopal Church (up from 16 last year) who approved Year B liturgical materials for the Season of Creation (September 1 – October 4), produced by the Diocese of Western Massachusetts. CCDLI distributed the materials to all clergy in the diocese.

Our Missioner continues to be available to visit any parish to preach on the environmental crisis and opportunities to take action to address it. But you don't have to wait for a parish visit to get involved! Just email us (creationcare@dioceseli.org) and we'll add you to the list. ### CATHEDRAL OF THE INCARNATION REPORT



Report to the 158th Convention of the Diocese of Long Island "My house shall be called a house of prayer for all peoples." (Isaiah 56:7)

Since 1885, the Cathedral of the Incarnation has stood as a House of Prayer for Long Island. Received as a gift by the first Bishop of Long Island, the cathedral remains a sacred gift to the diocese—a treasure meant to be shared from the Brooklyn Bridge to Montauk Point.

As a place dedicated to divine encounter and spiritual renewal, the cathedral opens its doors to all: members of parishes and missions of the diocese, those of other faith traditions, the cathedral's own congregation, and members of the broader community. It is our hope that, over time, all members of the diocese will come to see the cathedral as their own—both a spiritual home and a central place of connection, alongside their local parish.

#### The Heart of Our Diocesan Community

The Cathedral of the Incarnation serves as the principal gathering and sending church in the Diocese of Long Island. Beyond its daily and Sunday worship, it hosts the diocese's most significant ceremonies: ordinations, consecrations, confirmations, reaffirmations, and many other rites that bind us together in faith. The cathedral's mission is to be a living example of the Christian life, where faith proclaimed is seamlessly woven with faith in action through mutual service and outreach.

Our primary vocation is to make the Incarnation known—to exemplify the inseparable bond between Christian contemplation and the active expression of faith in community life.

## Welcoming All in a Changing Landscape

In today's rapidly evolving religious landscape, where many identify as "spiritual but not religious" (SBNR), the cathedral plays a uniquely public role. We embrace these seekers with open arms, welcoming all who yearn for a deeper connection to the divine. Our mission in this era is to see every spiritual seeker as a companion on the journey, drawing them into the transformative power of the Gospel.

Our life as a cathedral is marked by an openness to new and diverse expressions of worship and community engagement, aiming to remain a vibrant center of Christian life in the 21st century.

## **Highlights of Cathedral Ministry**

Guided by the Holy Spirit, the leadership of our bishop, and the dedication of cathedral clergy, staff, and countless laypeople, the cathedral's ministries continue to evolve. Here are some key developments:

1. **Rhythm of Prayer**: Daily prayer is at the heart of our community. We currently celebrate a weekly Healing Mass on Wednesdays at noon along with regular opportunities to participate in the Daily Office. We look forward to the return of the Daily Mass in 2025. Weekend liturgies have been expanded to include Saturday night through Incarnation Chapel in Carle Place building upon the full round of cathedral services on Sundays.

- 2. **Worship Space Restoration**: In 2024, we completed the restoration of the cathedral's historic High Altar, returning it to its original 1885 splendor. A new boiler was installed, ensuring appropriate temperatures throughout the winter for worshippers and instruments! These efforts honor our past while preparing us for a sustainable future.
- 3. **Fellowship in Faith**: Our intergenerational fellowship and formation program on Sunday mornings at the Mercer School of Theology continues to thrive. Two liturgies, *Cathedral for Kids!*—a dynamic 30-minute service—and the outdoor *Neighborhood Mass* have become key elements of our outreach, drawing in diverse participants, including families and pets!
- 4. **Incarnation 2030**: We have launched a revised masterplan to transform the cathedral's buildings and grounds into a vibrant center for diocesan life. This includes creating more green space for reflection through road removal, repurchasing 32 Cathedral Ave. to expand housing, developing the Walker Retreat House in collaboration with the Mercer School, and renovating See House to support both diocesan and cathedral staff.
- 5. **Prison Ministry**: The cathedral's ministry at Nassau County Jail is expanding, now serving both incarcerated men and women, as well as providing support to the staff. With over 14 dedicated ministers, this work exemplifies our call to serve the most vulnerable among us.
- 6. **Feeding Ministries**: Led by Deacon Denise Galloway, our feeding program has grown significantly, nourishing both bodies and souls on the streets of Hempstead. This ministry is not just about providing food—it's about fostering relationships that strengthen and uplift our communities.
- 7. **Resourcing Parishes**: Our clergy and staff are actively engaged in supporting parishes across the diocese, offering expertise on liturgy, outreach, music, and formation, as well as helping to develop partnerships that enhance our collective mission.
- 8. **Deanery Ministry**: The cathedral is spearheading a regional mission strategy, involving clergy and lay leaders in a collaborative approach to worship, stewardship, and outreach that enriches the life of our broader deanery across central Nassau County.

#### A Call to Join in the Work

My hope for this convention is that you share in the enthusiasm I feel for these ministries, which belong to all of us. I invite you to visit the cathedral, participate in its life, and experience firsthand the joy, depth, and transformative power of our shared ministry at the heart of the diocese in Garden City.

May we continue to journey together, empowered by our faith, inspired by our traditions, and committed to serving all who seek a deeper connection with God.

# The George Mercer Jr. Memorial School of Theology Report to the 158<sup>th</sup> Convention of the Episcopal Diocese of Long Island

It is with great pride and gratitude that we present this report on the recent endeavors of the George Mercer Jr. Memorial School of Theology. We continue to embrace our mission of supporting the spiritual and academic growth of the Diocese through innovative programming, ministerial formation, and expanded resources. As we reflect on the past year, we celebrate our community's resilience and adaptability in meeting the evolving needs of both clergy and laity.

### **Programs and Services**

Mercer School programs span two academic semesters, from September to June, providing a robust calendar of educational opportunities and spiritual formation. In addition to our theological offerings, we also extend meeting support services to congregations, diocesan organizations, and external groups. Thanks to recent investments in technology, we are now able to offer hybrid meetings, seamlessly integrating in-person gatherings with virtual participation via Zoom. This capability allows us to stay connected across the diocese while continuing our commitment to "One Diocese, One Mission."

## **School for Ministry**

One of Mercer's core focus areas is the School for Ministry, which offers comprehensive academic and spiritual formation for postulants and candidates pursuing the vocational diaconate. This fall, we are honored to serve eleven postulants and candidates, as well as twenty-four clergy and lay members auditing courses. Our curriculum includes essential disciplines such as Scripture, Church History, Theology, Liturgics, and Homiletics, fostering both intellectual and spiritual growth.

In addition, the Mercer Scholarship Fund has provided financial support to six EDLI seminarians attending residential seminaries, enabling them to pursue their theological education without undue financial burden.

### Looking Ahead: Priesthood Formation Program

We are excited to share our plans for a future degree-granting, graduate-level program tailored specifically for postulants and candidates for the priesthood. In partnership with Codrington College in Barbados, we will offer a full academic and pastoral education rooted in the six canonical areas required for priestly formation: Theology, Church History, Scripture, Ethics/Philosophy, Worship, and Practical Theology. We anticipate launching this program in the 2025–2026 academic year, providing postulants with a transformative and thorough formation experience.

## Continued Learning: "Lunch and Learn" and Training Programs

Our well-received "Lunch and Learn" series continues to be a popular offering, providing accessible, online short courses in scripture, theology, and liturgy. These one-hour sessions, held over three or four consecutive Thursdays, have drawn consistent attendance, with an average of 20–25 participants per session. The flexibility of this online format allows more people to engage with theological education in the midst of their daily routines.

While Zoom has allowed us to sustain educational offerings during the pandemic, we recognize the ongoing demand for in-person training. This year, we successfully held two in-person sessions for Eucharistic Visitor training, reaffirming our commitment to hands-on ministry support.

#### Safe Church Program Revamp

Mercer has worked diligently with Chancellor Jim Weller to revamp the diocesan Safe Church program. We now offer key policy documents in five languages on the EDLI website, making them accessible to a broader audience. The online training option remains the most efficient and widely used method for parish compliance, helping us safeguard our communities.

## **Mercer Library Expansion**

Our efforts to enhance the Mercer Library's resources are ongoing. With holdings valued at \$750,000 (excluding archives), we continue to expand access to valuable theological materials. After extensive research, we have implemented the OCLC EZproxy system, which now provides seamless access to online databases through EBSCOhost and JSTOR for Mercer students, faculty, alumni, and EDLI clergy. This new system is fully operational, and our librarian, Jane Herbst, is available to assist with navigating these expansive resources.

#### Financial Overview

The Mercer School operates on an academic year from September to June, but our financial reporting follows the Diocese's fiscal calendar. In 2023, the School of Theology operated with revenue of \$894,520 and expenses of \$834,309, resulting in an increase in net assets of \$60,211. These figures reflect our continued financial health, supported by the Mercer Scholarship Fund, and our commitment to prudent stewardship of our resources.

#### Conclusion

As we look to the future, we remain steadfast in our mission to nurture and equip the next generation of clergy and lay leaders in the Diocese of Long Island. Through a blend of academic rigor, spiritual formation, and practical ministry support, Mercer continues to evolve, ensuring that we meet the needs of our diverse and growing diocese.

### CENTER FOR SPIRITUAL IMAGINATION REPORT



#### Report to the 158th Convention of the Diocese of Long Island

The Center for Spiritual Imagination was established in May, 2020 at the Cathedral of the Incarnation in Garden City, NY, in response to the profound changes unfolding across America's religious landscape. Since its founding, the Center has sought to re-envision the treasures of the Christian contemplative tradition, offering them in ways that promote spiritual formation, fostering tranquility, courage, and a deepened sense of community. The Center's mission is to cultivate a spirituality that is both inclusive and responsive, addressing the complexities of the 21st century with generosity, commitment, and hope. Co-founded by Canon Kristin Vieira Coleman, the Very Rev. Canon Dr. Michael Sniffen, the Rev. Canon Adam Bucko, and the Rev. Canon Morgan Ladd, the Center continues to be supported by a variety of independent grants, with significant backing from the Hemera Foundation, the Center for Action and Contemplation, and Duke Divinity/Lilly Endowment. Over the past year alone, the Center's programs, situated at the crossroads of contemplation and justice, have engaged thousands of people seeking spiritual direction rooted in the Christian tradition.

At the heart of our work is prayer, which led to the founding of the new monastic Community of the Incarnation in Fall 2020. This community has quickly become one of the fastest-growing religious communities within the Anglican Communion. Part of the new monastic movement, the Community of the Incarnation draws from the deep wells of ancient spirituality, infusing them into contemporary life. It embraces three rich charisms: the Benedictine way, which invites members to live mindfully, attuned to God's presence in daily events; the Carmelite way, which calls them into the inner desert of the heart, experiencing silence as a source of transformation; and the Franciscan way, which fosters a life rooted in simplicity, nonviolence, and justice, reminding us that our spirituality must bear fruit in love and compassion for the world. The community also observes three accountabilities: to God and one another through the 12 steps of recovery, to the poor through the lens of liberation theology, and to the earth through an earth-centered spirituality that recognizes creation as a place of divine revelation.

Our four-year formation program is a comprehensive journey that integrates classes on contemplative spirituality and theology, small group work informed by 12-step principles and CPE methodology, retreat experiences, personal mentoring, and a commitment to living by our rule of life. Currently, 50 individuals are in candidacy, preparing to either take vows or join the community as companions, with an additional 18 novices in formation. One of our signature programs, a class on contemplative prayer for daily life, has 120 participants this year, and our weekly online public meditation draws over 200 attendees each month, connecting people from all over the world in shared prayer and contemplation. Recently, we

were honored to witness the solemn vows of our first cohort, marking their lifelong commitment to the practices of new monasticism.

Our community has also nurtured new leadership and ministries, including "Black Lives and Contemplation," which has engaged 75 participants in its first year. This program explores the contemplative traditions of individuals of African descent in the United States, offering participants a broader understanding of both Blackness and contemplation, and deepening their own spiritual lives. Additionally, our newly vowed members are beginning to guide companions in their spiritual journeys, teaching contemplative prayer and leading studies of our rule of life.

Last year, we launched the "Spiritual Imagination" speaker series, featuring prominent figures like Fr. Richard Rohr and Dr. Melanie Harris, and highlighting how contemplative prayer remains the beating heart of the Christian tradition. This series has offered profound insights on how this practice can address the wounds of the modern world and offer a path toward healing.

Looking ahead, we are excited to announce the upcoming launch of a new training program designed to empower those who have completed our formation to become teachers of contemplative spirituality and spiritual directors. This program will combine deep formation, experiential learning, and academic classes on the history of Christian contemplative theology. Our goal is to train leaders who can ensure that the church continues to be the church, helping to initiate people into the experience of God, where we can all discover our belovedness in God.

## REPARATIONS COMMITTEE DIOCESAN CONVENTION REPORT

The Reparations Committee is a subcommittee of the Diocesan Council. Committee membership consists of the Chair - Penny Grinage, Dr. Dee Laffin, Rebecca Maines, Linda Watson-Lorde, Dr. Michelle Chester, and the Very Reverend Gideon Pollach. In 2021, Bishop Lawrence Provenzano charged committee members to develop a system to grant college scholarships and trade union fee awards for African Americans and Caribbean Americans who continue to face discrimination resulting in unjust treatment due to racial intolerance and socioeconomic disadvantages.

The intent of this scholarship program is to offer an opportunity and promote equity for recipients to improve both their education and lives. This reparations program was established to fulfill the promise of The Episcopal Church's Becoming Beloved Community.

The scholarship program was named the <u>Barbara C. Harris Scholar's Program for Truth and Reparations</u> with the consent of the Right Reverend Alan Gates, former Bishop of the Diocese of Massachusetts, and the Harris family. The Right Reverend Barbara C. Harris (1930-2020), was an activist, journalist, teacher, leader, visionary, civil rights advocate, and first female bishop and first female black bishop within the Anglican Communion. She was also a descendent of enslaved African people.

The Barbara C. Harris Scholar's Program for Truth and Reparations scholarship program is advertised predominantly through our Diocesan parishes and sent to high schools and trade schools within the four counties of the diocese: Kings, Queens, Nassau, and Suffolk. Applicants are not required to be members of the Episcopal Church to apply for a scholarship or fee award.

For the 2023-2024 academic year, the Reparations Committee received 85 completed applications. There were 80 academic applications and 5 trade/vocational applications. Students indicated their aspirations for attaining a college degree in diverse fields such as law, applied physics, forensic science, pre-medicine, economics and international affairs, mechanical engineering, biology, industrial and labor relations, electrical repair, computer technology, and auto mechanic repair. After careful selection based on the criteria set forth by the committee, the twelve (12) scholarship recipients, were recognized and presented with their certificates by the Right Reverend Lawrence C. Provenzano, Bishop of the Diocese of Long Island, during a special Juneteenth ceremony at the cathedral which was followed with a reception on the lawn. Each scholarship award recipient received \$5,000 and it is sent directly to their respective schools. This year's scholarship recipients also received a copy of Bishop Barbara C. Harris' memoir, <a href="Hallelujah">Hallelujah</a>, <a href="Anyhow!">Anyhow!</a>, which was signed by Bishop Provenzano. The Most Reverend Michael B. Curry: Presiding Bishop of the Episcopal Church, gave the keynote address via video.

Approximately 275 people from across the diocese attended this third diocesan celebration of Juneteenth which is now observed as a federal, state and city holiday to recognize the emancipation of enslaved African people in the United States. It is the day that news of the signing of President Lincoln's Emancipation Proclamation reached Galveston, Texas, on June 19, 1865, finally freeing the slaves in Texas, two and a half years after it was signed. The Reparations Committee deemed Juneteenth as an appropriate day to present these scholarship awards recognizing that education was forbidden to slaves in order to keep them oppressed

The Reparations Committee expresses gratitude to Bishop Provenzano for his vision and support to the reparations committee enabling them to achieve this important work for our diocese as well as for The Episcopal Church. We are also grateful to the various clergy, diocesan ministries, and diocesan staff members who supported this initiative and helped bring it to fruition.

# REPORT OF THE HISTORIOGRAPHER OF THE EPISCOPAL DIOCESE OF LONG ISLAND

A Historiographer is someone who studies how history has been written and kept. In the Episcopal Diocese of Long Island this role is represented by the official Archivist and Historiographer. The Mission of the Archives of the Episcopal Diocese of Long Island is to strive to provide access to the members of its community and all others who have an interest in its history and faith. They aim to preserve and safeguard the history of the Diocese and its faith in order to continue to effectively serve and educate the community.

The records of the Diocesan Archives primarily date back to the formation of the Episcopal Diocese of Long Island in 1868, though a small selection of records predate this formation back to when the Diocese was still a part of the Episcopal Diocese of New York. The Diocesan Archives consist of collections regarding the following subjects: Parish Files (closed and open parishes), legal, real estate, publications, and miscellaneous Episcopal organizations.

The Diocesan Archives is also open to general research beyond the community of our Diocese. It is the job of the Archivist to help researchers locate relevant materials that may aide individuals in their work. Just in the past year the Diocesan Archives has consistently provided in person access each month to many local and internationally based researchers, as well as many more via online communication. From students to authors, the information and records in Diocesan Archives has or will be featured in school projects and published books. It is important to the Diocesan Archives that they are advocates of the materials to not be forgotten but instead to be shared and remembered when possible.

Th focus of the Diocesan Archives over the past year has been on structuring parish records in a way that makes then more effective and locatable throughout the research process. This collection of materials is broken into two sub collection, open and closed parishes. The Diocesan Archives is responsible for maintaining records not only from all open parishes but also all records from closed parishes dating back to the first appearance of the Episcopal Church on the long Island territory. These collections tend to consist of materials such as incorporation papers, consecration papers, historical materials, directories/yearbooks, news clipping, pictures, insurance, real estate, finances, legal matters, vestry minutes, correspondences and much more. Along with the general parishes materials the Diocesan Archives is responsible for all sacramental registers from primarily closed parishes. They are used to serve persons seeking certified copies of baptismal, marriage, confirmation and burial entries, and persons exploring family history.

## **VOTER QUALIFICATIONS MEMO**



TO: All Clerical and Lay Delegates DATE: October 31, 2024

**FROM:** The Rev. Anthony Jones, Secretary of Convention

SUBJECT: Committee on Voter Qualifications (Rules of Order) Concerning

Qualifications of Delegates and Parishes to Vote at Diocesan Convention

In accordance with the Rules of Order adopted in November 2021 the Committee on Voter Qualifications "shall examine all audit certificates, parochial reports, delegate certificates, in order to make recommendations to the Convention as to the right of any Delegate or Parish wishing to have a right to vote at Convention." The Committee "shall submit its reports to the Convention recommending the seating or rejection of each delegate or parish wishing to have the right to vote at Convention to the extent such is permitted by the Canons of the Church or of this Diocese." (Rules of Order Part III, Rule 1(c) and Part IV, Rule 2(d).)

The Diocesan Canons provide the following with respect to:

<u>Delegate Certificates</u>: "The Secretary of the Convention shall prepare a list of Delegates, Alternates, and Youth Delegates and place it before the Convention on the first day of its meeting. Irregular or defective certificates and certificates and documents relating to contested seats shall be reported by the Secretary of the Convention when organized, for its action. The Secretary of Convention shall also read at this time the list of delinquent Churches, Congregations, and Missions reported to or by the Bishop under these Canons." (Title II, Canon 4, Section II(c).)

<u>Parochial Reports</u>: "Whenever any Parish, Congregation, or Mission shall be in default by more than sixty (60) days in filing the Parochial Report required by the National Canons and by this Canon, the Bishop shall report such Parish, Congregation, or Mission to the Convention and such Parish, Congregation, or Mission shall thereby forfeit its seat and right to vote of its elected Lay Delegates and Alternates to the Convention. Such right may be restored to a Parish, Congregation, or Mission, however, upon application to the Convention after filing all reports as to which it may be in default" and on such terms as shall appear just. (Title V, Canon 2, Section III.)

<u>Audits</u>: "Whenever any Parish, Congregation, or Mission shall be in default in filing the certificate of audit, the Bishop or Ecclesiastical Authority shall report such Parish or Mission to the Convention, and such Parish or Mission shall thereby forfeit its seat and right to vote of its elected Lay Delegates and Alternates to the Convention. Such right may be restored, however, upon application to the Convention after filing all reports as to which it may be in default" and upon such terms as shall appear just (Title V, Canon 3, Section III.)

Accordingly, a list of delinquent delegate certificates, parochial reports and audits will be provided to the Committee on Voter Qualifications following which will make its recommendations at the opening of the Convention based on their examination of this material. Delegates are encouraged to ascertain that their congregations have complied with all the reporting requirements before attempting to register for the Convention.

# RULES OF ORDER OF THE CONVENTION OF THE DIOCESE OF LONG ISLAND

## Part I. Matters Occurring Prior to the Convention.

RULE 1. Reports Presented to the Convention. All reports of Diocesan Corporations, Diocesan Institutions, Governing Boards, Committees, Officers, etc. to be presented to the Convention as required by the Diocesan Canons or otherwise shall be transmitted to the Secretary of the Convention not later than six (6) weeks prior to the date of the Convention in every year. The Secretary of the Convention shall cause the same to be reproduced and mailed or electronically transmitted to every Delegate to the Convention and all persons holding any office or trust under the Convention not less than two (2) weeks prior to the date of the Convention as part of the Pre-convention Journal.

RULE 2. <u>Submission of Resolutions</u>. All resolutions to be considered for action by the Convention must be submitted in writing to the Secretary of the Convention not later than thirty (30) days prior to the date of the Convention and must be signed by a Delegate to the Convention. On the expiration of the time for submitting resolutions to the Secretary of the Convention, the Secretary of the Convention by direction of the President of the Convention shall transmit to the Committee on Miscellaneous Business or such other appropriate Committee or Commission of Convention all resolutions submitted to the Secretary of the Convention after such date, but no such resolution shall be proposed for action by the Convention except upon a motion for the suspension of the Rules of Order duly passed.

# Part II. General Regulations.

- RULE 1. <u>Admission to the Convention</u>. The Bishops of the Church, Clergy from other Dioceses, Professors and Students of Theology in the Church, and all persons holding any office or trust under the Convention, if not members, shall be admitted to sittings of the Convention. Seats on the platform shall be occupied by officers of the Convention or their representatives, by Bishops, and by such other persons as by special vote of the Convention shall be so authorized.
- RULE 2. <u>Admission to the Convention During Balloting</u>. No person, other than legally elected Delegates to the Convention and all persons holding any office or trust under the Convention, or such persons as may be approved by the President as necessary to the immediate business of the Convention, shall be permitted to appear on the floor of the Convention during a period of balloting by the Convention for all elective offices.
- RULE 3. <u>Visitors and Other Observers</u>. There may be an area of the Convention meeting room designated by the President for visitors and other observers. This area shall not be considered as a part of the Convention Floor.
- RULE 4. <u>Hours of Business</u>. The hours of each day's session shall be as set forth in the Pre-convention Journal, unless otherwise ordered by the Convention by direction of the President. Each session shall begin and conclude with prayer.
- RULE 5. <u>Distribution of Printed Matter</u>. No printed (<u>or electronic</u>) matter of any kind shall be distributed at the Convention nor shall any printed matter be placed on the seats of Delegates except by the authority of the President of the Convention, but this prohibition shall not apply to the report of a Committee or Commission of Convention, or to any paper or electronic transmission or other document presented to and accepted by the Convention or printed by its authority.
- RULE 6. <u>Unanimous Consent</u>. By unanimous consent any action may be taken that is not in contravention of any provision of the Constitution or the Canons of the Church or the Diocese.
- RULE 7. New Business. All new business introduced, except such as may accompany and form a part of the report of a Diocesan Corporation, Diocesan Institution, Governing Board, Committee, Officer, Committee, or Commission of Convention, shall be in writing and as a motion or resolution in complete form for adoption with the name of the mover appended. Such new business shall at once be referred to an appropriate Committee or Commission of Convention. It shall be the duty of such

Committee or Commission to which such resolutions and motions have been referred to report them to the Convention in the order of their reference. Convention shall take action only on the report of such Committee or Commission unless the Convention shall otherwise order.

RULE 8. <u>Suspension of Rules</u>. Any Rule of Order may be suspended by the vote of not less than two thirds (2/3) of the Delegates present. Any new matter introduced during such suspension may be explained by the mover in a statement of not more than five minutes, but otherwise shall not be subject to debate or action until after report from the appropriate Committee or Commission of Convention.

RULE 9. Amendment of Rules of Order. No proposed amendment of the Rules of Order shall be considered by the Convention unless it shall in the Pre-convention Journal and mailed or electronically transmitted as provided in Part I, Rule 1 of these Rules of Order. If such amendment were adopted by a majority vote of the Convention, it shall lie over to consideration until the next annual Convention when, if again adopted by a majority vote, the Rules of Order shall be amended accordingly. If such amendment were adopted by unanimous vote of the Convention or by a two-thirds (2/3) vote of both Orders taken separately, the amendment shall take effect immediately.

### Part III. Order of Business.

RULE 1. <u>Organization for Business</u>. At the opening of each Convention, the President shall take the chair after which the Order of Procedure shall be as follows:

- (a) <u>Roll Carld</u>. Every Delegate, Clerical or Lay, shall file with the Secretary of the Convention a record of attendance on a "Roll Carld" or such other electronic means of recording attendance as the Secretary of Convention shall determine and disclose by means of the Pre-convention Journal so that the names of all present may be recorded in the Diocesan Journal.
- (b) <u>Determination of Quorum</u>. In order for the Convention to conduct business, a quorum must be present. A quorum shall consist of at least sixty (60) Clergy entitled to vote in the Convention, and Lay Delegates from at least sixty (60) Parishes entitled to vote in the Convention. The Secretary of the Convention shall ascertain the presence of a quorum of Clergy of the Diocese and Parishes entitled to representation, and report this to the President of the Convention. If there be any irregular or defective certificates, and certificates and documents referring to contested seats, these shall be reported to the Convention, which shall decide on the admission of the Delegates named therein after submission of the report of the Committee on Voter Qualifications.
- (c) <u>Report of Committee on Voter Qualifications</u>. The Secretary of Convention shall present the report of the Committee on Voter Qualifications.
- (d) <u>Order of Business</u>. A quorum being present, the President shall declare the Convention organized for business which shall proceed following the order listed in the Pre-convention Journal and shall include in any order the the Secretary of the Convention determines:
  - (i) <u>Appointment of Parliamentarian</u>. The President of Convention shall appoint a Parliamentarian for the good order of the Convention.
  - (ii) Appointments of Tellers of Elections.
  - (a) The President of Convention shall appoint from members of the Clergy Canonically Resident in the Diocese, and Laity domiciled in the Diocese, Tellers of Elections (one Delegate each from the Clergy and Laity for each ballot box used). Upon direction of the President, the Secretary of Convention may appoint additional Delegate tellers to count the ballots who need not be Delegates to the Convention in order that the official tellers may not be obliged to absent themselves from the business of the Convention while the ballots are being counted.
  - (b) If the Convention or voting at the Convention is held electronically, no tellers shall be appointed, and the counting of the ballots shall be accomplished by such electronic means as shall be directed in the Pre-Convention Journal.
  - (iii) <u>Reading of Minutes</u>. The minutes of the prior Convention as printed in the Diocesan Journal or the Pre-convention Journal, as determined by the Secretary of the Convention, shall be read and approved, but the requirement to read

such minutes may be dispensed with upon order of the Convention as directed by the President.

- (iv) <u>Unfinished Business</u>. If the business of the Convention shall not have been completed on the first or any succeeding day of session, the first business on each succeeding day shall be the matter under consideration at the time of adjournment on the preceding day and thereafter the matters which were not reached on the preceding day, in the order prescribed in these Rules of Order.
- (v) <u>Reports of Diocesan Corporations and Diocesan Institutions</u>. Reports of the following diocesan corporations and institutions shall be included in the Pre-convention Journal:
  - (A) The Standing Committee
  - (B) The Diocesan Council
  - (C) The Board of Managers of Camp DeWolfe
  - (D) The Cathedral of the Incarnation
  - (E) Episcopal Ministries
  - (F) The Mercer School of Theology
  - (G) The Trustees of the Estate
  - (H) Episcopal Health Services
- (vi) Report of the Secretary of Convention. The Secretary of Convention shall report on communications received by him or her for the Convention, or on business unfinished at the last Convention. Introduction and reference shall be made to Committees on Miscellaneous Business or on Canons of any resolutions not in the Pre-convention Journal which are either (A) included in the report, printed and previously distributed, either of a Committee or Commission of the Convention, or (B) relating to or embodying a recommendation contained in the Bishop's Address.
- (vii) Reports of Committees.
  - (A) On Canons
  - (B) On Miscellaneous Business
  - (C) Other Committees and Commissions of the Convention
  - (D) On Dispatch of Business
  - (E) On the Bishop's Address (which shall be in order at any time after the Bishop's Address)
- (viii) Report of Treasurer.
- (ix) Elections as Required by Canon.
  - (A) The Secretary of Convention
  - (B) Assistant Secretary or Secretaries of Convention (who shall be nominated by the Secretary of Convention)
  - (C) The Treasurer of Convention
  - (D) Assistant Treasurer or Treasurers of Convention (who shall be nominated by the Treasurer of Convention)
  - (E) The Standing Committee
  - (F) The Diocesan Council
  - (G) The Board of Managers of Camp DeWolfe
  - (H) The Cathedral of the Incarnation
  - (I) Episcopal Ministries
  - (J) The Mercer School of Theology
  - (K) The Trustees of the Estate
  - (L) Disciplinary Committee
  - (M) Delegates to the General Convention
  - (N) Provisional Delegates to General Convention
- (x) <u>Appointments to Diocesan Corporations and Institutions.</u> The President shall, at the discretion of such President, appoint from members from the Clergy Canonically Resident in the Diocese, and Laity domiciled in the Diocese, to any

Diocesan Corporation or Institution as provided by the Canons of the Church or this Diocese.

- (xi) <u>Appointments to Committees</u>. For the next meeting of the Annual Convention the President shall, at the discretion of such President, appoint from members of the Clergy Canonically Resident in the Diocese, and Laity domiciled in the Diocese, to the following Committees:
  - (A) On Canons
  - (B) On Dispatch of Business
  - (C) On Miscellaneous Business
- (xii) The Bishop's Address. The Bishop's Address shall be in order at any time.
- (xiii) <u>Reports of other Bishops</u>. Reports of the Bishop Coadjutor and of the Bishop Suffragan and the Assistant Bishop if so requested by the Bishop.
- (xiv) Resolutions and References and Motions.
- (xv) The Holy Eucharist. The Holy Eucharist shall be in order at any time.

#### Part IV. Convention Committees.

- RULE 1. <u>Establishment of Convention Committees</u>. To facilitate its work, the Convention may from time to time establish such committees with such duties as it may determine, and, unless otherwise stated, the President shall appoint members thereto, as provided in the following Rule 2.
  - RULE 2. Committees. There shall be the following Committees of Convention:
  - (a) <u>Canons</u>. The duties of the Committee on Canons are to consider and report on all matters appearing in the Pre-convention Journal or introducing in Convention referred to it by the Bishop. Its membership shall be up to four (4) Clerical Members, up to four (4) lay persons of the Diocese, and the Chancellor, ex officio, each member to serve for four (4) years with one (1) Clerical Member and one (1) lay person to be appointed by the President prior to each Annual Convention and announced in the Pre-convention Journal.
  - (b) <u>Dispatch of Business</u>. The duties of the Committee on the Dispatch of Business are to arrange and facilitate the manner of conducting the business of Convention. Such Committee shall always be entitled to the floor of Convention on business pertaining to that Committee. Its membership shall be the chairperson of the Committee on Canons, ex officio, the chairperson of the Committee on Miscellaneous Business, ex officio, the Chancellor, ex officio, the Secretary of Convention, ex officio, and up to nine (9) other persons appointed by the Bishop from the Clerical Members and Lay persons of the Diocese. Members of the Diocesan staff may, as required by the President, serve as part of the planning group for this Committee.
  - (c) <u>Miscellaneous Business</u>. The duties of the Committee on Miscellaneous Business are to consider and report on all matters appearing in the Pre-convention Journal or introduced in Convention referred to it by the Bishop. Such Committee shall receive and consider all resolutions except resolutions on matters coming under the purview of an appropriate Committee or Commission of Convention, and except resolutions of Committees accompanying Committee reports recommending action of the Convention. The Committee on Miscellaneous Business shall submit its report to the Convention recommending the adoption or rejection of each resolution proposed, or the adoption of any such resolution as amended or substituted by such Committee. A copy of the report of the Committee on Miscellaneous Business shall be mailed or electronically transmitted by the Secretary of the Convention to each Delegate as part of the Pre-convention Journal. Its membership shall be a chairperson and up to four (4) clerical members and up to four (4) lay persons of the Diocese, each to serve for four (4) years. Appointments to the Committee, if any, shall be announced in the Pre-convention Journal.
  - (d) On Voter Qualifications. The Committee on Voter Qualifications shall be under the oversight of the Secretary of the Convention. Its duties are to consider and report on all matters pertinent to the qualifications of Delegates and Parishes wishing to have the right to vote at Convention. Prior to the opening of Convention it shall examine all audit certificates,

parochial reports, and delegate certificates, in order to make recommendations to the Convention as to the right of any Delegate or Parish wishing to have a right to vote at Convention. The Committee on Voter Qualifications shall submit its report to the Convention recommending the seating or rejection of each Delegate or Parish wishing to have the right to vote at Convention to the extent such is permitted by the Canons of the Church or of this Diocese. Its membership shall be the chairperson of the Committee on Canons, the chairperson of the Committee on Miscellaneous Business, the chairperson of the Committee on Dispatch of Business, the Chancellor, the Secretary of Convention, and the Treasurer of Convention.

(e) <u>Membership, Term and Vacancies</u>. The term of office of each Committee member shall continue to the close of the Convention which shall sit in the member's last year of service, and thereupon the successor's term shall begin. The Bishop shall fill by appointment any vacancy in any Committee caused by resignation, death, or inability to act.

#### Part V. Decorum and Debate.

- RULE 1. Robert's Rules. Except when in conflict with the Constitution or Canons of the Church or of this Diocese or any Rule of Order herein contained, the latest edition of "Robert's Rules of Order" shall govern the interpretation of these Rules of Order and the procedure to follow.
- RULE 2. <u>Resolutions to be Seconded and in Writing</u>. No resolution shall be considered as before Convention unless seconded and reduced to writing and signed by the mover, whose name shall be entered in the Diocesan Journal.
- RULE 3. Order of Amendments. All amendments shall be considered in the order in which they are received. When a proposed amendment is under consideration, a motion to amend the same may be made.
- RULE 4. Withdrawal of Motion or Resolution. The mover may withdraw a motion or resolution at any time before decision or amendment, in which case it shall not be entered upon the Minutes.
- RULE 5. Respect for President and Scope of Debate. When any Delegate is about to speak, he or she shall, with due respect, address himself or herself to the President, and in speaking confine himself or herself to the point in debate.
- RULE 6. <u>Limit on Debate</u>. No Delegate shall speak more than twice in the same debate without leave of the Convention (except the mover, who is entitled to reply).
- RULE 7. <u>Transgression of Rules</u>. If any Delegate in speaking or action transgresses the Rules of Order of the Convention, the President shall call him or her to order, and he or she shall immediately take his or her seat, unless permitted by the Convention to explain or proceed in order.
- RULE 8. Motion, Debate, Vote, Priority. The following motions shall have priority in order listed. The mover cannot interrupt a Delegate who has the floor, he or she must be recognized, and the motion must be seconded.
  - (a) To Adjourn or to Recess not debatable, majority vote
  - (b) To Lay on the Table or to Table not debatable, majority vote
  - (c) To Move the Previous Question, or Limit or Extend Debate not debatable, amendable as to time if specified, two thirds (2/3) vote
  - (d) To Postpone to a Time Certain debatable, amendable, majority vote
  - (e) To Commit or Recommit to a Committee debatable, amendable, majority vote
  - (f) To Amend or to Substitute debatable, amendable, majority vote
  - (g) To Postpone Indefinitely debatable, not amendable, majority vote
  - (h) To Suspend the Rules or Take up Business Out of Order not debatable, two thirds (2/3) vote
  - (i) To Divide the Question not debatable, majority vote
  - (j) To Reconsider must be made on the day the vote is taken, may not be reconsidered more than once, must be moved and seconded by ones who voted in the majority on the first decision, debatable, two thirds (2/3) vote

RULE 9. <u>Balanced Budget</u>. No motion to amend the budget shall be entertained that would cause the budget to be out of balance with known pledges and estimated other receipts unless there is included in the motion to amend a provision for maintaining a budget balanced against known pledges and estimated other receipts. Such motion shall be in writing.

### Part VI. Committee of the Whole.

- RULE 1. <u>Committee of the Whole</u>. Whenever so ordered, the Convention may go into Committee of the Whole for the consideration of any matter. The President shall designate some member of the Convention to act as Chairperson of the Committee of the Whole, which, when in session, shall be governed by these rules as adapted by the Chairperson, subject to appeal to the Committee, and also to the following provisions:
- (a) Motion to Rise. A motion to rise and to report to the Convention, with or without request for leave to sit again, may be made at any time, and shall take precedence of all other motions, and shall be decided without debate. No such motion once made shall be renewed until further proceeding shall have been had in the Committee of the Whole.
- (b) <u>Motion to Vote at a Designated Time</u>. A motion that a vote upon any pending proposition shall be taken at some designated time may be made and be disposed of without debate at any time, but as before provided a motion to report to the Convention shall take precedence.

Motion to Lay on the Table. No motion to lay on the table shall be entertained.

RULE 2. Motion for Committee of the Whole to Sit Again. No debate shall be allowed in the Convention of any motion to permit the Committee of the Whole to sit again. Requests for such permission shall take precedence of all other business, and the motion thereof shall be put to vote immediately without reference.

# Part VII. Elections and Voting.

- RULE 1. <u>Voting of Members</u>. Every Delegate to Convention present shall vote whenever a question is put, unless excused by the Convention. The votes shall be taken by electronically or by ayes and nays.
- RULE 2. <u>Voting by Convention</u>. In all elections other than a vote by Orders, a simple majority of votes shall be necessary for election, with a majority of Delegates voting. In the event that more candidates receive a majority than there are offices to be filled, those candidates receiving the highest majorities shall be declared elected to each office. In each case, additional ballots shall be taken if needed until the offices in question are filled. The Secretary of the Convention, assisted by tellers appointed by the President of the Convention, or by authorized electronic voting, shall have charge of the counting of the ballots. Defective and blank ballots are invalid. A ballot cast for less than the number of offices or seats to be filled shall not be deemed to be defective. For paper ballots, After they have been given to the voters, the President may, in the discretion of such President, opt to take a five-minute recess before casting the ballot. In the event of electronic voting, no such recess shall be granted.
- RULE 3. <u>Vote by Orders</u>. A vote by Orders shall always be taken whenever required by the Constitution or Canons of the Church or of the Diocese. A vote by Orders may also be called for by ten (10) Delegates to Convention. In all stated elections where a vote by Orders is required, a concurrent majority of both clerical and lay votes shall be necessary for election, with a majority of both Orders voting. In the event that more candidates receive a majority in both Orders than there are offices to be filled, those candidates receiving the highest concurrent majorities shall be declared elected to each office.
- RULE 4. <u>Vote by Certain Officers</u>. The Convention Secretary, Diocesan Treasurer, Diocesan Chancellor, and Diocesan Registrar, whether clergy or lay, elected or appointed, shall be entitled to vote at all Convention elections and on all questions put to Convention.





